

Our thanks to those who gave of their time and talents to bring us the WSO 2020 Fall Convention, "Dipping into the Wine country in Newberg, Oregon". The coordinated efforts of the Newberg convention co-chairs Patrice Cameron and Anji Grainger and the many volunteers who worked with them to find a way to retain a significant portion of the planned events in all areas through the use of virtual platforms and videos were evident. The exhibition was put to video again by Ken Cramer; from the video we chose a "People's Choice" award winner. Our juror Kristi Grussendorf selected 20 top award winners, and provided video comments regarding her selection process for each. Those comments were skillfully woven into the virtual exhibition by our webmaster. The presentation of the Outstanding Service Award (presented to Beth Verheyden), and the Lifetime Artist Award (presented to John Bradley), were also captured on video and can be viewed on the WSO website. The WSO 100 Club held its usual convention fundraising activities through the use of Constant Contact, and videos of the raffle proceedings were

also posted to the WSO website. Our virtual exhibition will be available for viewing on both the WSO website and that of the Parrish Gallery in the Chehalem Cultural Center where our paintings will hang through November of 2020.

Juror Kristi Grussendorf graciously agreed to select the exhibition works online and allowed us to offer both a virtual 90 minute demo, and a 2-day mini-workshop and paint along. Both were appreciated and enjoyed by all who participated. Our technical and communications teams – Rob Robinson, Ken Cramer, Del Moore, Carol Putnam, Elizabeth Zimmerman, Tara Choate and Paul Bourgault again exceeded all expectations. Thank you, truly, all – members, volunteers, and Kristi, for your positive attitude and willingness to attempt new things. You did such a fine job!

I know you probably hear this from every juror but I'm going to say it, too. The caliber of your artists is high and the quality of your paintings is exceptional. The task of whittling down to 80 entries was challenging but being able to live with these paintings and getting to know them was a real privilege. Thank you again for the opportunity! I really wish I could be there with you teaching in person and seeing the actual paintings. Paint quality has always been so important to me and it's just impossible to get a fully accurate read for example on granulation or transparency from a jpg. Regardless, I'm confident about my award picks and have sent a video pointing out some of the fabulous qualities of my favorite 20 paintings so check it out if you're interested. Since I talked about the aspects I used to jury this show, I won't go into it again here but suffice it to say, it's a good mix of very objective observations and my own personal more subjective reactions. I've often heard artists describe the jury process as a "crap shoot" to which I take exception (there's a reason the same artists continue to win awards) but

I do want to encourage anyone who didn't get into this one to continue to enter pieces you believe in because there is, of course, differences in the artistic preferences of different jurors.

In closing, please know I am holding all of you artists, your society and all of Oregon in my heart. Our entire world is going through so much and now you've got fires, too! I think art is even more important during times like these. As artists we look more closely, see more clearly and are able to communicate in a truly universal fashion. Whether you paint inspirational & beautiful things, uncomfortable truths, or the familiar and mundane, keep sharing your vision. And, if you paint to escape, that's good, too. "Just Do It!"

Since 1850, when the American Society of Painters in Watercolor was founded, watercolorists have joined together in national, state, and regional societies. The American Watercolor Society, which evolved from the earlier organization, and the National Watercolor Society emerged in 1866.

The Watercolor Society of Oregon began in 1966 with 38 members. Its purpose was "to further the interest of transparent watercolor painting and to encourage a wider experience, enjoyment, and education to the painter and the viewing public." Its bylaws provided for semi-annual meetings in April and September, each hosting a juried show which would travel throughout the state for a year. The first slate of officers included: Fred Smith, President; Tom Allen, Vice-President; Gertrude Rigdon, Secretary-Treasurer; and Peg Stuart, Tour Chair. In the beginning, only transparent watercolors were admitted to the shows, but in 1975, it was decided to admit all aqueous media on paper to the spring show.

Since 1966, when the original membership was 38, the Society blossomed by traveling around the state of Oregon gaining new members in this outreach. By 1985 the membership reached 500, and by 2012 it was nearly 1000.

Early jurors for the semi-annual shows were members of the Society, but in 1980 the Society began to engage nationally-recognized professional artists as jurors. Each juror conducts a workshop in conjunction with the meeting. The first professional juror was the late Millard Sheets who returned to jury the 20<sup>th</sup> anniversary show in 1985.

The opportunity to exhibit and participate in peer and professional critiques, workshops, and artistic networking have benefitted Watercolor Society of Oregon members for over five decades. The professional camaraderie continues to encourage growth and creative excellence, promoting watercolor painting across the state.

WSO is a 501(c)(7) as determined by the IRS.
