What's this got to do with WSO Conventions? They bring our diverse membership together two times a year. WSO members live all over Oregon in such places as Terrebonne, Eagle Point, Damascus, Maupin, Blue River, Siltcoos Station, Dorena, Gold Beach, Neotsu, and Burns. Watercolor is infectious; a yearning to share and learn. Eager painters, two times a year, drive the black, red, and blue lines of the map to gather together. We meet each other, share, learn, collaborate, and see the juror's selection of 80 members' paintings. We drive to gathering places with facilities such as fairgrounds, events centers, and hotels. The host locations require a few willing members to administer a convention which can be reflective of the territory. WSO's Convention Council Chair, currently Anji Grainger, provides each local chair with WSO's step-by-step Convention Handbook and personal guidance. WSO Treasurer, currently Peg Patterson, provides financial guidance and support.

<u>The Pour It On</u> logo for the Eugene Conventiion was a rainbow of 8 inverted umbrellas. An open umbrella is supported by staves attached to the center. Ruth Armitage of Oregon City and Margaret Godfrey from Blue River were the handle; their Dream Team, the staves and fabric. Convention chairs do not work alone. They tap the right person for the right job for the various parts of the three-day convention. When asked, willing WSO members step up for Saturday's breakout and paint out sessions.

WSO Membership Roster and Handbook, page 2, informs us of who-does-what within the Convention Council. The WSO Board, and committees within the Councils, play a direct role in putting your conference on the map. GPS and Siri are not involved.

Thank you WSO membership for your participation. You are my sunshine.

# IN MEMORIAM



#### In Memory of Michael Hill

Saturday, January 14, 2017 was a sad day. We lost a valuable member of WSO, Mike Hill at the age of 74. Mike's talent as an artist was and is appreciated and well known. He has been featured in many prestigious art magazines, was a recipient of many art awards, and a principle artist of the Forest Grove Concours d'Elegance for many years. Mike painted a huge mural depicting scenes of the community of 1919 that hangs in the Gresham City Hall Chambers.

He not only was a talented artist, but also enjoyed politics, sports, and became a very strong advocate for education. Mike was a loving husband and father, and for years Mike served Gresham as an accomplished dentist.

Painting as a young person was influenced by his mother, who was a commercial artist. She encouraged his sense for color, texture, and the effect of the brush. He studied commercial and graphic art at the California School of Fine Arts. Mike started painting seriously about 16 years ago with classes at Mt. Hood Community College and found his passion with watercolor. He wrote "I like to think of my work as realism with an attitude." Some of his favorite subjects were automobiles, street scenes, and special people. For the last 14 years, I was so fortunate to be one of 5 artists who painted together above his dental

office, where his studio was. Of course a little wine assisted our critiquing ability, and Mike called us "painting under the influence." Our treasured time painting together will forever be a valued memory of learning, sharing, laughter, and friendship. Art does that! One time when Mike was a juror he reported, "I love the translucency and vitality of the medium and the satisfaction it gives me, my friends, my collectors, and family."

I will share my favorite quote from him that we can all identify with, "Life is precious and even more precious when you can recreate it on paper."

Most of us who knew Mike will always remember his endless energy and contagious laughter.

Mike is survived by his wife Jeanine, daughters Andrea M. and Pitchaya K. and grandson Bryce. His presence will be greatly missed.





#### In Memory of Don Burgess

Don Burgess passed away at home on March 22, 2017. Don had been a member of WSO since 2002. Don called himself "a car guy." His love of cars began early and remained with him throughout his life. He expressed his passion for hot rods in his realistic watercolors. Don had been involved with art since childhood. Twice he was chosen to be one of 50 kids from his grade school to participate in an art program at the University of Washington. But when he got older he put away his paints and pursued his career in retail appliance sales as well as his hobby of hot rod cars. He managed the departments at Montgomery Ward, Eugene Planing Mill, and Fletcher and Smartt Appliance Sales Parts & Service in Eugene.

It wasn't until he was older that he rediscovered his desire to create art. He said, "I was probably at a car show and got inspired." For the past several years, he was actively involved as a member of the Board of Directors with the Emerald Art Center in Springfield, organizing gallery functions and workshops.

When Don retired from retail sales he focused on his artwork, taking classes and workshops at the Emerald Art Center as well as belonging to an art study group at River Road Park and Recreation. Don said that two artists influenced his art the most: Jeanne Hammond Elliot and Judy Morris. They taught him to plan the drawings for his paintings before putting any paint on watercolor paper. He also participated in hot rod shows and won many trophies for his restored crème colored '67 Chevelle Super Sport with gold interior. He made many trips to the Bonneville Salt Flats in Utah for *Speed Week* that combined his two favorite subjects to paint: hot rods and the Red Rock Desert. Don said, "I paint things that please me, cars and deserts. I paint for myself, it's not a business to me."

Don's wife, Ginny, who he married in 1957, and their daughter Valerie and her partner Jul survive him.

### **BOARD ACTION** *February and April* 2017



*By Amanda James* (In order to decrease the length of this combined February and April 2017 Board Action Report some of the less

significant or repeated board actions have been omitted. Full Board Minutes are posted on WSO website and WSO Facebook page.)

On February 18, the WSO Board met at the Knight Library on the U. of O. Campus in Eugene. **President**, **Kathryn Damon-Dawson** called the meeting to order at 12:40 pm. 10 Board members and 13 committee members were present.

**Secretary's Report, Amanda James** included board e-mail votes concerning reimbursement for transporting the Traveling Show.

**Convention Council, Anji Grainger** Tupper Malone presented a motion to increase the hanging fee; it was seconded by Ruth Armitage. The motion passed unanimously. The increase will take effect starting with the Fall 2017 Exhibition. The hanging fee will increase from \$10 to \$30 for each accepted painting. \$10 will remain with the WSO100 Club, and \$20 will be included in the WSO general fund.

**Convention Committee Reports** Ruth Armitage and Margaret Godfrey gave a short update. The Convention budget has a potential profit of \$30,615 due to the generosity of the Jordan Schnitzer Museum of Art. Ruth suggested that WSO members should consider becoming JSMA members.

Exhibition Shipping Chair, Sandra Wood is now in charge of this committee.

**Exhibition Location Chair, Zsuzsanna Vamos** now holds this position.

**Past President, Rob Robinson** has received 79 responses to his volunteer survey. Some of the respondents have already accepted jobs. He will administer this survey yearly.

**Treasurer's Financial Report, Peg Patterson** reviewed the 2016 Profit and Loss Statement, which showed a \$20,754.76 net income.

**Publications Council, Paul Bourgault** suggested that the November and May editions of the *Watermark* could be digitally published.

Administrative Council, Tupper Malone reported that 11 years of slides have been converted and are available on the WSO website.

Historian, Kathy Tigard introduced the new Historian, Alisha Whitman.

Membership Council, Mila Raphael reported there are 750 total members, 512 active, 186 Lifetime, and 52 Subscribers. A motion was made and passed that WSO would no longer pay to forward returned member mail.

Awards Council, WSO 100 Club President, Geoffrey McCormack reported the 100 Club has a balance of \$187,372.

**Education Council, Margaret**

**Godfrey** announced that Ruth Armitage and Harold Walkup would be instructors at Menucha this year.

Meeting was adjourned at 2:40 pm.

#### April board meeting:

**President, Kathryn Damon-Dawson** called the meeting to order at 1:15 pm on April 7, 2017, at the Hilton Hotel in Eugene. 12 Board members and 10 committee members were present.

Convention Council, Anji Grainger advised the Board that there is no Convention Chair or firm location for the Fall 2018 Convention.

Anji Grainger moved and Mila Raphael seconded a motion to amend the policies and prospectus to require matte black metal frames for all exhibition paintings, beginning with the Fall 2017 Exhibition. The motion carried unanimously.

Convention Committee Reports: Fall 2017 Troutdale: Co-chairs Elizabeth Zimmerman and Mojdeh Bahar gave a brief update. There will be students available from the Mt. Hood Community College who will be volunteers in addition to WSO members. They plan to have a masseuse available at the convention.

Spring 2018 Florence: Chair Kathryn Damon-Dawson indicated that a contract has been signed with the Florence Events Center and Art Committee. She is selecting subcommittee chairs.

Spring 2019 Portland: Moya Lehman has secured an agreement with the Oregon Society of Artists for the show and reception.

Vice-President Beth Verheyden and Kara Pilcher presented a Convention Restructuring Proposal. The Board discussed the proposal but did not come to a consensus, and the proposal was tabled.

**Show Juror Liaison, Jenny Chen** continues in this position.

**Convention Registration, Barb Sulek** reported that the Eugene Convention has a total of 352 registered individuals comprised of 248 members with 104 guests.

**Past President, Rob Robinson** announced vacancies: Sandy Evans, Awards Chair; Jenny Armitage, Merit Awards Chair; Ruth Armitage Awards Council, Zola Sherwood, Stationery Chair, and Anji Grainger, Convention Consultant. Both Anji and Sandy are soliciting members who could shadow them for their positions.

**Treasurer's Financial Report, Peg Patterson** discussed the need for artists to provide their own insurance for paintings that WSO does not cover.

Vice-President/Public Relations Council, Beth Verheyden has secured a contract with Michael Reardon to be our juror for the Spring 2020 Convention. A discussion was undertaken regarding possible future jurors.

Administrative Council, Tupper Malone requested authorization of \$20 to pay access to Google in order to complete the slide conversion, which can be accessed by members. This motion passed unanimously.

Awards Council, Ruth Armitage extended special recognition to Sandy Evans for contacting all WSO critique groups and for her work in obtaining awards for WFWS.

Sandy Evans expressed thanks for all the adulations and promised to train her successor as she had been trained by Jennie O'Connor.

Education Council, Margaret Godfrey announced that Harold Walkup will be teaching at Gold Beach and Tara Choate has contracted with equestrian artist Ruth Buchanan to teach a workshop.

Western Federation of Watercolor Societies WSO Delegate, Margaret Godfrey thanked Ruth Armitage and the many volunteers who made this exhibition possible.

Old Business, Kathryn Damon-Dawson and Peg Patterson reported that the WSO 1995 Articles of Incorporation need amending to reflect its 501(c)(7) status and will pursue this and report at the June Board Meeting.

Meeting was adjourned at 3:00 pm.

### CHANGES FOR WSO EXHIBITIONS

Many of you participated in the fabulous Spring 2017 Convention in Eugene and heard



the news about the changes coming for show submissions. For those of you who were unable to attend there are two changes that will affect your painting submissions.

The first change is something that many of us on the WSO Board have been thinking about for quite some time. When we walked into the Jordan Schnitzer Museum of Art and saw how incredibly beautiful our show looked, the Board decided that this is how we want future WSO shows to appear. We now have a new framing requirement. Frames shall be matte black metal frames only. If you get a chance to see the show before it closes on June 19, you will immediately understand how wonderful this change is.

The second change is one that the WSO Board has deliberated over very carefully and believes that this is the best solution for our group. WSO is a nonprofit organization and must look at rising costs and how we can best generate revenue with the smallest impact on our membership. So rather than increasing our membership dues again we have made a change in our hanging fee. WSO still will not charge an entry fee for show submissions; however, the hanging fee will increase from \$10 to \$30. The increase in the fee will only affect those who are accepted into the show.

Both of these changes will go into effect beginning with the Fall 2017 Watercolor Exhibition in Troutdale. I look forward to seeing the fabulous paintings you submit for this show.

### JEANNIE MCGUIRE Workshop

It was a privilege to chair Jeannie McGuire's workshop that was held nearly two weeks before our confer-



ence. There were 25 enthusiastic participants, including several out-of-state Western Federation of Watercolor Societies' members. Like many of you, we were in awe of her stunning international award winning paintings and the long list of initials following her name. Yet, when we met and talked with Jeannie, we soon discovered how approachable, fun, and generous she is with her knowledge.

Jeannie started us out by instructing us to paint an 18-inch wide eye; then we progressed to three individual portraits, one full figure, and a group portrait. She worked hard to inspire us to take risks to create memorable "museum quality" portraits. She encouraged us to make up stories about the people in the photographs whose images we painted. Rather than paint background scenery or objects to tell the story, she challenged us to use our brush strokes, shapes, and colors to express and develop the character of the people.

Rene` Eisenbart received instructions and equipment from Del Moore, our audio and video expert, and set up an overhead camera; projected on the screen, we clearly saw the bold yet gestural brushstrokes that Jeannie uses as she demonstrated her intuitive style of painting. "Personalities" were created, changed, and evolved right before our eyes. It was helpful to see Jeannie struggle, change her mind, and just "try something" until she produced the story she wanted to tell. But we also saw that it was

OK for Jeannie to change her mind and go in a different direction or even put the painting away until she knew how to proceed. It was a good lesson to watch an expert painter not just "work her magic" but be reminded of all the hard work, determination, concentrated thought process, and time it takes to hone one's skills and vision that are necessary to create a work of "Art" with a capital "A."

#### **Breakout Sessions**

Susan Gunter - Delegate Tour of Public Art: Delegates and their guests enjoyed an art tour on Friday afternoon. All the artwork in the Hult has been created by Oregon artists. The original curtain was recently retired due to extreme wear. The new curtain will have the original woven detail projected onto it at the beginning of each performance. The woven ceiling panels in the Silva Concert Hall were made in Albany.

While we saw a variety of art throughout the Hult, one highlight was a series of black and white ceramic tiles, with just a hint of red for interest, that run the length of the lobby restrooms. In the women's room the tiles depict women applying their make-up in various poses, and in the men's room, gentlemen are fixing their ties. After the Hult tour we walked to two local galleries. The White Lotus focuses on Asian art. And the Karin Clark has more contemporary pieces on display. It was a pleasant way to spend a cold and windy Eugene afternoon.

Jean Ludeman - Exploring

**Eugene:** Patrice Cameron gave a wonderful tour for the 23 participants. We headed out of town on a big yellow school bus to the Cascades Raptor Center. The Cascades Raptor Center has one of the largest collections of native raptor species in the Pacific Northwest with nearly 50 birds of



prey in large outdoor aviaries. The setting is in a lovely wooded area, and visitors can take a selfguided tour of the grounds. We were privileged to see a large variety of raptors from several species of owls, hawks, bald eagles, and golden eagles. They even house the "ultimate recycler" – the vulture. Most of the raptors we saw cannot be returned to the wild because of an injury or being raised in captivity.

Linda Shelton - Stronger Design: Before and After: Linda Rothchild-Ollis's two-part, Power Point presentation of painting images of 15 artists, who had been chosen by lottery, was specific and constructive. In part one, Linda introduced and guided her audience using compositional layouts and elements and principles of design. We



were able to visualize in a new way, how the image (before) was transformed into a stronger painting (after). In part two, Linda showed images of selected artists; Judy Morris, James Maria, Jeannie McGuire, and four others, whose work exemplified Linda's part one study. She enabled us to see new possibilities with more objectivity.

*Note:* All WSO members who would like pdf files of the Principles of Design, Elements of Design, and the Golden Mean-Rule of Thirds worksheet may request it by emailing Linda.

Susan Kingzett - Marbling to Masterpiece: Liz Walker and René Eisenbart humorously and expertly introduced each other as marbling artists. René gave a presentation of the marbling process. Liz and René each follow the guidelines of marbling expert, Galen Berry. To begin the process, alum, which is dissolved in water, is sponged onto deli paper. Then size, a thick liquid, is made by blending gelatin (carrageenan) with water; the size is poured into

a shallow tray. Several colors of acrylic paint are sprinkled onto the surface of the size. Combs and rakes are then drug through the paint to create patterns. A sheet of the alum-treated paper is laid on top, and it absorbs the floating colors. Finally, the paper is rinsed and hung up to dry. We all enjoyed their clear and concise presentation.

Susan Gunter and Tina Mae Fels - Supplies for Art Aren't Always Art Supplies: Geoff McCormack led us through a variety of techniques he uses to create smooth, blemish free backgrounds for his paintings. He has painted on a



wide variety of objects, i.e. a car, refrigerator, airplane, blenders, and more, which have consequently given him a chance to experiment with alternative art supplies.

To get those thin, straight lines he uses #233 plus green tape, which is available at most auto supply stores. It must be #233 plus. Others with similar numbers do not work. The tape comes in several sizes; the smaller width is more useful for creating tighter curves than those that are a little wider. It is easy to create a nice sweeping curve with the tape when you apply it by arching your arm.

This tape can be used on cold or hot press paper. It will not pull up or disturb the fibers. It must be burnished to stop paint from bleeding under it. Geoff recommends Arches paper for the best performance, with Fabriano a close second. Some problems with Strathmore can occur. When removing the tape, Geoff said, it is important to pull back on the tape itself and not to pull straight up. This lessens the chance that the fibers will be pulled up and the paper distressed.

Another tip Geoff gave us is to add "Paint Ease" by Wagner to our paint. This is a good wetting agent and cuts the surface tension. Wet the paper first and then apply the paint with a sponge for a smooth background.

These were just a few of the techniques Geoff taught in his presentation. We came away with many new ideas to try.

**Rose West - Juror Critique:** Often Jeannie McGuire's first question to courageous participants in the critique session was, "What is your intention?" After hearing from the artist, Ms. McGuire gave insightful comments to a full house of attentive listeners.

It was about story. "You could give this painting a story, if you want to. Think about the mood here...help us feel what she is feeling."

It was about senses. "I like the texture...I can feel...I can taste...sense of a wind blowing...paint what the music sounds like."

It was about shape. "Where does the shape take you...instead of lines, shapes...I would like to see it divided, repeated...elaborate more of the shapes to butt up

against the line work...takeoff on the curves...follow-through to follow out...I like to see things connected to the outside...the reality shape and the made-up shape, they mimic each other."

It was about color and contrast. "It's an area you can add some deeper color...use the color to show the relationships...switch the value...bolder, brighter...a graphic design reason to punch it up...I am not going to tell you what color to use...how to do that."

It was about encouragement. "Allow yourself to explore...I like that the eyes read differently...I love the flow...everything is handled so nicely."

"I am giving my opinion about this." We were all grateful that she did so.

**Bonnie Moore - You Be the Judge:** Dyanne Locati presented us with a wealth of information to consider what a juror might look for as he or



she decides which paintings should be included in a show. A few of her insights include: "Does the painting rise above the subject?" "Is there fresh vision in the subject or

### *design?" "Does the artist push color or contrast?"*

Dyanne also reminded us that every judge and juror has had paintings rejected. She cautioned us to never paint to please a judge or juror, but rather "paint your passion!" She emphasized that before we enter a show, to read the prospectus carefully and to ask ourselves, "Does my artwork fit?" "Do my submissions exhibit a similar style?" (Don't mix smooth pieces with textured pieces.) She warned us to never make changes to our artwork once it has been submitted. And she exhorted us to remember: "It takes courage to enter a show." "You will never win if you're not in the race." "Good luck! Never give up!"

#### **Robin Berry - Taste of Oregon**

**Paint Out**: Plein-air painters gathered on a chilly Saturday afternoon at the 5<sup>th</sup> Street Market Place to paint with Leslie Cheney-Parr, Harold Walkup, and Susan Spears. These artists demonstrated and shared insights about the challenges of adjusting one's setup for the changing April weather.

The sun came out for a while, and many participants joined Harold Walkup and Susan Spears in the upstairs courtyard and balcony area and painted the sunlit shops and architecture. But even though the rains returned, most everyone stayed the course, shifting setups and adding layers of clothing. Below the balcony several other artists worked along with or watched Leslie Cheney-Parr sketch and paint the lower

Linda Rothchild-Ollis - 3 Artists, 3 Approaches: An intrigued audience watched three very talented artists paint from the same reference image, of a man sitting on a bench, in their own particular style. Del Moore, our audio and video expert, created a system with three screens and three cameras, which made it possible to follow each artist simultaneously. Nancy Frances Cheeseman acted as moderator. Moving from artist to artist, Nancy encouraged each artist to share how they started their painting, what were their favorite palette and paper preferences, and what was the motivation that moved their process along.

Deborah Marble, a professional courtroom artist, started her paintings with a pencil sketch indicating the outer points of the figure. She used a ruling pen or a "Needle Tip Applicator Bottle" (available at JoAnn's), which she filled with Indigo watercolor paint mixed with some water. Deborah worked quickly and loosely, observing the gesture of the body, as she developed not only the original figure but two more as well.

Chris Stubbs started her painting with a drawing on 300 # watercolor paper. She did her preliminary drawings on Duralar .005 Matte Film. Once she wet the paper, she dropped in rich colors to "do their thing." She used large flat brushes to define edges and cover large areas of the paper, as well as Winsor Newton Monarch Bright brushes (range #2 - # 12) to lift lights and soften edges. One of her new favorite colors is Daniel Smith Aussie Red Gold.

Peggy Stermer-Cox began with multiple drawings. She said that she draws the subject multiple times to capture the flow of ideas that start around the 4th drawing of a subject. Sometimes she continues to draw 6 or 12 versions. "My process takes time," Peggy said. Then she scans her drawing to enlarge it. Peggy prefers Sable brushes that provide a soft touch that doesn't disturb existing under layers. Peggy applied the complements of Perinone Orange and Prussian Blue watercolor to her painting in thin washes. She used underlaying and overlapping layers to build up rich color and value transitions. At the end of the painting, she added texture using opaque paints or ultramarine blue.

#### Marcia Morrow - Jeannie

**McGuire Lecture:** Jeannie McGuire gave a Sunday morning Power Point presentation and lecture on her progression as an artist as well as how her portraits and figurative paintings have changed from being predictable to dynamic.

Jeannie, who resides in Pittsburgh, Pennsylvania, has been influenced by the industrial history of the city. She invents stories about the faces and figures in her reference photos that give life to them and help her to express what she wants the viewer to come away with. She chooses color and brushstrokes and shapes to express the sensual quality of the faces and figures, and their settings - the strength of a ballet dancer's back, the grime in an iron worker's face, a cool wind blowing. Often she edits out everything but what she considers the most important part(s) she wants the viewer to see. She showed us a portrait of a man that included

just the eyes and forehead and bridge of the nose.

Jeannie encouraged us to experiment and try new ways of painting. She said we must be bold, original, and paint from our souls in order to grow as artists. It may feel unsafe at first, but the outcome may be an award winning painting. She urged us to keep all our unfinished paintings and assured that we would eventually grow into their completion as we took more risks.

## MEMORIES TO LAST A LIFETIME



*By Beth Verheyden* For as long as we've been looking forward to and planning the WFWS and WSO combined shows, it's hard to believe it's now
